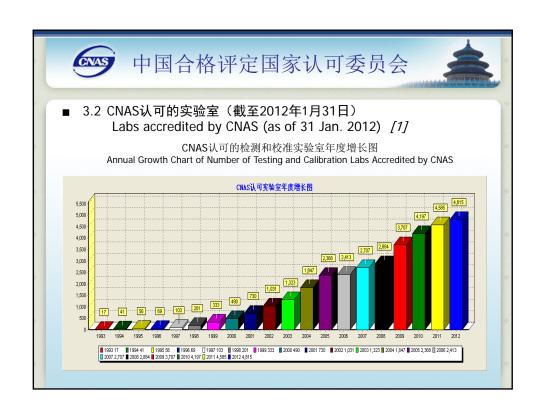

Validation audit to certified organizations. (Extraordinary)

Risk management of accreditation to certification bodies. (Graded management)

The change in organic product standard

新版《有机产品》国家标准总计修改161处。其中第1部分

(生产)修改91处;第2部分(加工)修改48处,第三部分

- (标识与销售)修改14处,第四部分(管理体系)修改8处。
- In <Organic product> new edition, in 161 places have been modified, includin 91 corrections in Section 1 (production), 48 corrections in Section 2 (processing), 14 corrections in Section 3 (mark and sale), and 8 corrections in Section 4 (management system).
- 主要修订考虑: Major concerns are:
- 1.与欧盟、美国等国家或地区有机产品认证法规和标准接轨,如转换期规定、投入物质列表
- 1. In consistance with standard of organic product in EU, US etc. e.g. on conversion rules, list of substance input.
- 2.充分考虑了我国国情,如人粪尿的使用
- 2. Substantial consideration of China situation, e.g. excrement of human.
- 3.标准对于有机生产的要求更为严格,如一年生作物不允许平行生产、产地环境要求

5.3 2012年 有机产品认证机构认可政策调整思路 Changes to policies on accreditation of organic product CB in 2012

- 一、受理和策划阶段 Acceptance and Planning
- 1、按照国家认监委发布的《有机产品认证目录》重新调整了有机产品认证认可的范围。 CNAS从2012年3月1日起执行新要求。(如蜜蜂养殖及蜂产品) < catalog of organic product certification>, was published by CNCA, adjusted scope in both certification and accreditation. This has been implementing on 1st Mar 2012. (Bee feed and
- 2、关注2011年专项检查的结果并将相关问题作为例行评审输入While conducting assessments, take result of last special assessment in 2011 as input
- 3、考虑到有机认可的高风险性,CNAS需根据机构的实际情况适当增加评审抽样量及见证 评审的频次要求等。High level of risk in organic accreditation must be considered. CNAS decides increase in frequency and samples of assessment, due to operation of bodies.

5.3 2012年 有机产品认证机构认可政策调整思路 Changes to policies on accreditation of organic product CB in 2012

- 二、评审阶段:强调评审关注重点: Assessment: focus on issues:
- 1) 对获证企业认证证书和标志的使用和控制,特别是标志使用数量的核查; apply and control of certificate and mark, especially the numbers of marks;
- 2) 对农业投入品的使用和控制; apply and control of agricultural input;
- 3) 检查组的配备composition of inspection group;
- 4) 产量衡算,产量与销售量的汇总核算; output balance, calculation of output and sales volume;
- 5) 产品检测项目的确定,在证书有效期内对所有产品进行检测的情况; confirmation of testing items, and circumstances of testing on every product in the validity term of certificate.

- 7) 现场检查时机的确定; confirmation of time in on site inspection
- 8) 例行监督检查和不通知检查,检查频次满足《有机产品认证实施规则》等相关要求的情况; general inspection and inspection without notification, frequency satisfies < Implementation rule of organic product certification > and related issues
- 9) 是否有超范围认证的情况whether carry out certification outside its scope

- (一) 针对专项监督检查发现的问题,要求认证机构限期进行深度整改,整改不满足要求的暂停认证认可资格。When issues has been discovered during following up, CB is required to take corrective actions. If it is not satisfied, qualification must be suspended.
- (二)对于4家检查员数量不能满足要求的认证机构。缩小相应认可范围。 There are 4 CB whose inspectors are not enough, their scope has been
- (三)对1家超出行政审批范围颁发认证证书且,及未在规定时间内获得认可的 认证机构,进行书面告诫,并要求限期整改。1 over administrative scope CB, which has not been accredited in time, is warned.
